



Terms of Service

1. Terms.

These terms of service are an agreement between your organization/school and NorthShore Athletics, Inc. dba Camp Jeff (hereinafter referred to as "Camp Jeff"), whose address is P.O. Box 5933, Buffalo Grove, IL 60089. By electing to use Camp Jeff, you are agreeing to the following terms and conditions ("Terms of Service").

If you do not agree to these Terms of Service or any part thereof, you may contact us at info@CampJeff.org to discuss a remedy, if permitted.

2. Duties; Effort.

Camp Jeff shall exercise its best efforts and professional judgment in operating the camp/clinic to comply with the organization/school's rules and regulations. The camp/clinic shall have access to the organization/school's facilities necessary for the operation of the camp/clinic and the safety of the athletes and participants, at no additional charge to Camp Jeff.

3. Financial and Billing Matters.

- (i) Camp Jeff shall charge a registration fee to all individuals attending the camp/clinic. Camp Jeff shall determine the amount of the registration fee, subject to the approval of the organization, and/or school's Athletic Director, which shall not be unreasonably withheld or delayed.
- (ii) An invoice outlining camp fees will be provided to the organization/school.
- (iii) All payments under this agreement shall be due to Camp Jeff no later than 7 days prior to the camp/clinic commencement. All amounts owed to Camp Jeff which are more than 30 days past due shall be subject to a late fee of 10% on the balance per month for each month or part of a month during which the payment is late. In the event Camp Jeff elects to retain an attorney to represent Camp Jeff in collecting any balance due, the organization/school shall also pay Camp Jeff reasonable legal fees and all other reasonable costs and expenses incurred to collect the balance due.
- (iv) Expenses.

Camp Jeff shall be responsible for paying all expenses associated with its instructors and related travel costs to conduct the camp/clinic, unless out-of-state travel is required or such travel is otherwise provisioned beyond what is outlined in Section 9 (Travel Fees).

- (v) Compensation.

Camp Jeff shall have the right to retain the net proceeds from the operation of the camp/clinic.

4. Registration, Camps Number Changes, and Cancellation.

- (i) Due to the understanding that school teams/rosters may not be finalized until late May, organizations may submit estimated athlete numbers until June 1st. Final numbers must be confirmed via info@CampJeff.org. After June 1st, invoices will be sent out based on the submitted athlete numbers submitted at registration. Organizations can adjust the number of registered athletes in accordance with the terms and camp registration timeline.
- (ii) Any camp cancellation or withdrawal, regardless of reason, occurring after registration and at least 30 days prior to the camp commencement date shall be subject to a \$750 cancellation fee.
- (iii) Within 30 days of the camp start date, the contracted camp duration or number of consecutive camp days may not be reduced (e.g., a 3-Day camp may not be reduced to a 2-Day camp). If additional days are requested (e.g., increasing from a 2-Day camp to a 3-Day camp), standard rates will apply and are subject to availability. If the camp duration is reduced, you will be charged the difference per registered athlete.
- (iv) For multi-day camps (2-3 days), the scheduled camp dates must run consecutively. If camp dates are split to accommodate your camp, additional camp, travel, and instructor charges may be applicable.
- (v) Changes to camp duration within 30 days of commencement incur a 50% cancellation fee per athlete per canceled day.
- (vi) Due to the nature of camp preparation including insurance and staffing, any adjustments/changes in camp roster numbers are due no later than 14 days before the camp commencement.
- (vii) Athlete reductions within 14 days but no later than 7 days before the camp start date will incur a 50% charge of the contracted rate per registered athlete.
- (viii) Within 14 days of your camp start date, if the number of athletes change that result in decreased instructors, you'll be charged for the instructors per instructor.
- (ix) Last-minute changes (within 7 days of the camp start date) are charged at 100% of the contracted rate per registered athlete, regardless of the reason for the cancellations and/or withdrawals.
- (x) In the event more athletes are added or attend the camp, the organization/school will be charged additionally per athlete at the contracted camp rate.
- (xi) Camps with 12 or fewer registered athletes will be charged at a flat rate outlined in Section 5 (Camp Pricing).
- (xii) There are no prorated rates for camps or for athletes participating in fewer than the full contracted camp duration, regardless of circumstances, including but not limited to injury.
- (xiii) All changes must be sent to info@CampJeff.org.

5. Camp Pricing.

- ❖ **Coaches:** There is no charge for active coaches to attend their team's registered camp(s).
- ❖ **Returning Camp Jeff Teams – Special Encore Rates:**
 Organizations that have registered for and successfully completed a camp within the past two years (e.g., 2024 and/or 2025) qualify for the Special Encore Rates outlined below.

This offer applies to new camp registrations through April 1, 2026.

- ❖ **Note:** Camp rates are subject to adjustment if extended instruction time or additional instructors are requested. The number of instructors included in standard camp pricing is outlined in Section 6 (Instructors). Additional instruction time or instructors may be provided at an additional cost.

6. Instructors.

To ensure an exceptional participant experience and safety, each camp shall include a minimum of two (2) instructors. Staffing will be determined by Camp Jeff and generally based on an approximate 11:1 athlete-to-instructor ratio, increasing incrementally with registration and subject to program needs, safety considerations, and camp structure. Camp Jeff can accommodate camps of all sizes without limitation. The following reflects example staffing guidelines based on registered athletes.

7. Conference Camps.

Conference Camps may be subject to different staffing ratios and contracted rates.

8. Additional Fees.**(i) Background Checks.**

Background checks required beyond Camp Jeff's standard checks will be covered by the organization/school including labor wages and travel costs. Requests must be made 21 days before the camp start date. All requests should be sent to info@CampJeff.org.

(ii) Insurance Requests.

If your organization requires an additional insured and/or endorsement, we can provide at the cost of \$100. All Certificate of Insurance (COI) requests must be made ten (10) days before your camp start date. All COI requests should be sent to Justin@CampJeff.org.

9. Travel Fees.

Due to rising fuel costs, Camp Jeff will be adding a fuel surcharge fee to each camp invoice. The distance calculated in miles will be mapped from 255 N. Buffalo Grove Rd., Buffalo Grove, IL 60089 to the camp location. The fuel surcharge fees will be applied as follows:

10. Organization/School Accommodations.

Lunch and/or dinner, based on scheduled camp hours, along with beverages, will be provided to Camp Jeff instructors each day of the camp/clinic at no additional cost.

11. Scheduling, Promotion, and Use of Organization/School Name.

(i) Prior Approval. No camp/clinic may be scheduled at the organization/school or promoted without the prior approval of the organization's and/or school's Athletic Director, which approval shall not be unreasonably withheld.

(ii) Policies and Procedures Compliance.

Camp Jeff shall comply with all School policies, regulations, and guidelines, and all local, state and federal laws concerning health, safety and public order.

12. Relationship Between Parties.

For the purposes of operating the camp/clinic, Camp Jeff's relationship to the organization/school shall be that of an independent contractor. Neither party shall have, nor hold itself out as having, the power or authority to bind or create liability for the other party by its intentional or negligent act or omission.

13. Coaches.

The organization/school agrees that the organization/school's team's coach(es) must be present at the camp/clinic to supervise its athletes. Camp Jeff will not be responsible for dealing with any team and/or athlete misconduct.

14. Indemnification.

(i) Camp Provider/Camp Jeff.

Camp Jeff agrees to indemnify and hold the organization/school, its officers, trustees, employees, agents, representatives, successors, and assigns harmless from and against all claims, losses, damages, or expenses of whatever form or nature, including attorney's fees and other costs of legal defense, whether direct or indirect, that they, or any of them, may sustain or incur as a result of any acts or omissions of Camp Jeff or any of its directors, officers, employees, agents, or representatives, including, but not limited to:

- (a) breach of any of the provisions of this Agreement;
- (b) the negligent or intentional act or omission of Camp Jeff or any of its directors, officers, employees, agents or representatives;
- (c) violation by Camp Jeff (or its directors, officers, employees, agents or representatives) of any laws, regulations, or orders.

(ii) Organization/School.

The organization/school agrees to indemnify and hold Camp Jeff, its officers, directors, employees, agents, representatives, successors, and assigns, harmless from and against all claims, losses, damages, or expenses of whatever form or nature, including attorneys' fees and other costs of legal defense, whether direct or indirect, that they, or any of them, may sustain or incur as a result of any acts or omissions of the organization/school or any of its trustees, officers, employees, agents, or representatives, including but not limited to: (i) breach of any of the provisions of this Agreement; (ii) the negligent or intentional act or omission of the School or any of its trustees, officers, employees, agents, or representatives; (iii)

violation by the School (or its trustees, officers, employees, agents, or representatives) of any laws, regulations, or orders.

15. Waiver Release.

The organization/school agrees that every athlete, participant, volunteer, and coach shall present to Camp Jeff, upon arrival, a waiver release as provided by Camp Jeff.

16. Media/Marketing.

The organization/school willingly agrees to allow Camp Jeff by means of photography and videography, to publish photographs and/or video of the camp facilities, athletes, and participants for advertising purposes in all forms of media. The organization/school consents to the use of said photographs or video without right to compensation of any type or form.

17. Opt-In Communications Consent.

By completing registration, the organization and its designated contacts expressly consent to receive transactional and promotional communications from Camp Jeff, including but not limited to emails, text messages, and phone calls, at the contact information provided during registration. This consent authorizes Camp Jeff to send information related to camp operations, updates, marketing, and future programs, and may be withdrawn at any time in accordance with applicable law.
